We keep certain basic information when you visit our website and recognise the importance of keeping that information secure and letting you know what we will do with it.



Cookies:

We may obtain information about your general internet usage by using a cookie file which is stored on the hard drive of your computer. A cookie is a small file which is placed on your hard drive when you visit our websites (directly or via our applications). We use information from cookies for purposes which may include:
